

## KEY TERMS USED

1. **Character:** Habits or dispositions of the heart or traits that make one to behave in one way or another.
2. **Contextualisation:** The process of rooting the gospel in local cultures and societies or the process of reflecting on the interaction between the text of the Word of God and the context as a specific human situation.
3. **Consecutive Polygamy:** The practice of having more than one wife, but one after another, by means of divorce and remarriage.
4. **Simultaneous Polygamy:** The practice of having more than one wife at the same time.
5. **Salient elements:** Key or outstanding features which drive or influence something or someone (for example, of a particular culture).
6. **Sola Scriptura:** Sola means “only” in Latin, “Scriptura” means Scripture. It is the belief that only Scripture should act as a primary guide and a final court of appeal for Christians in matters of faith and morality. Thus it does not literally mean *nuda Scriptura*.
7. **Monogamy:** The practice of being married to only one wife at a time as opposed to being married to more than one wife at the same time (Polygamy).
8. **Morality:** Literally: custom or “way of life”, code of conduct of individuals and groups.
9. **Ubuntu:** That which makes a human being to be human as opposed to an animal.
10. **Virtue:** A quality that makes someone to succeed as a person. That which makes a person to be a good specimen of the human kind.
