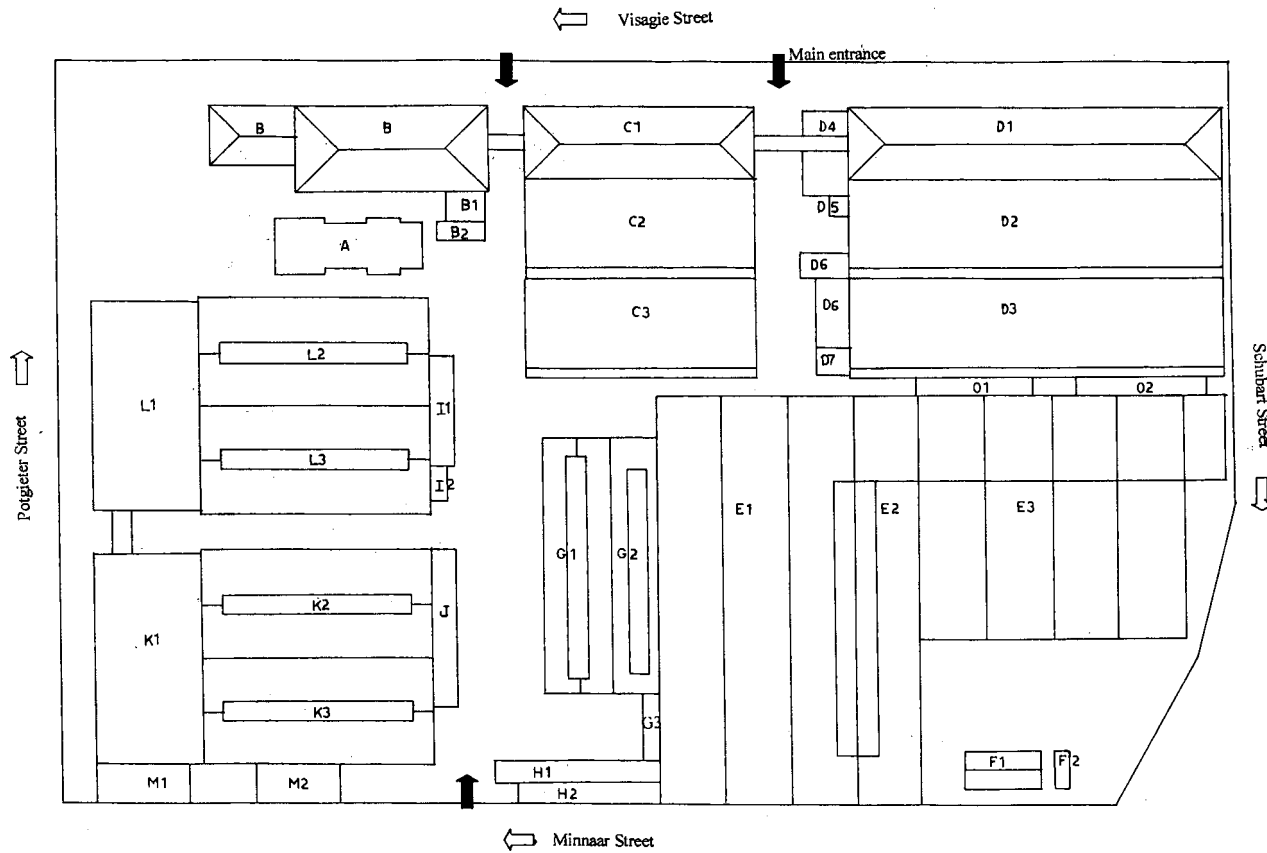


Figure 36: Existing Pretoria State Garage Buildings

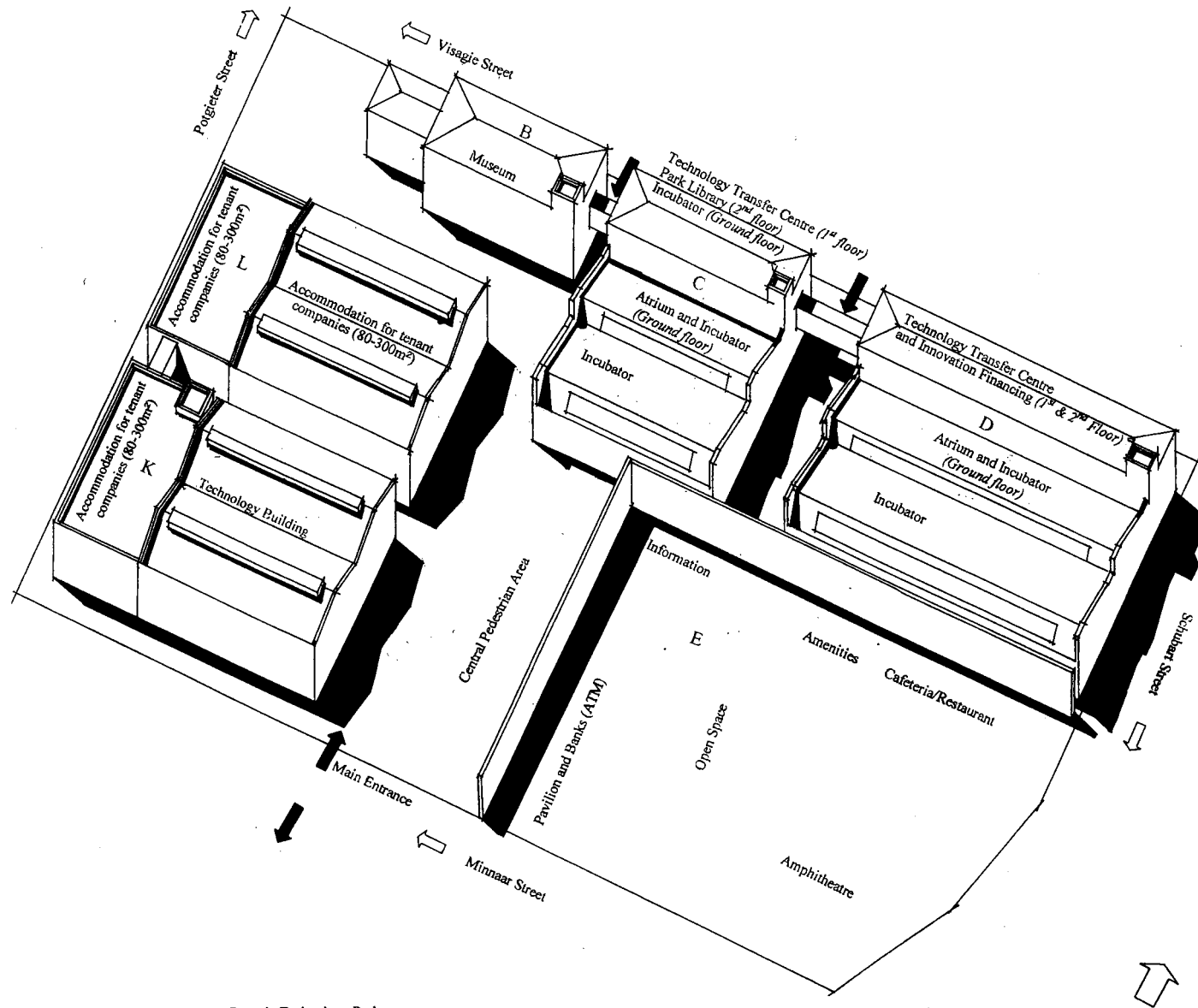


Figure 37: Proposed new activities and centres of the Pretoria Technology Park

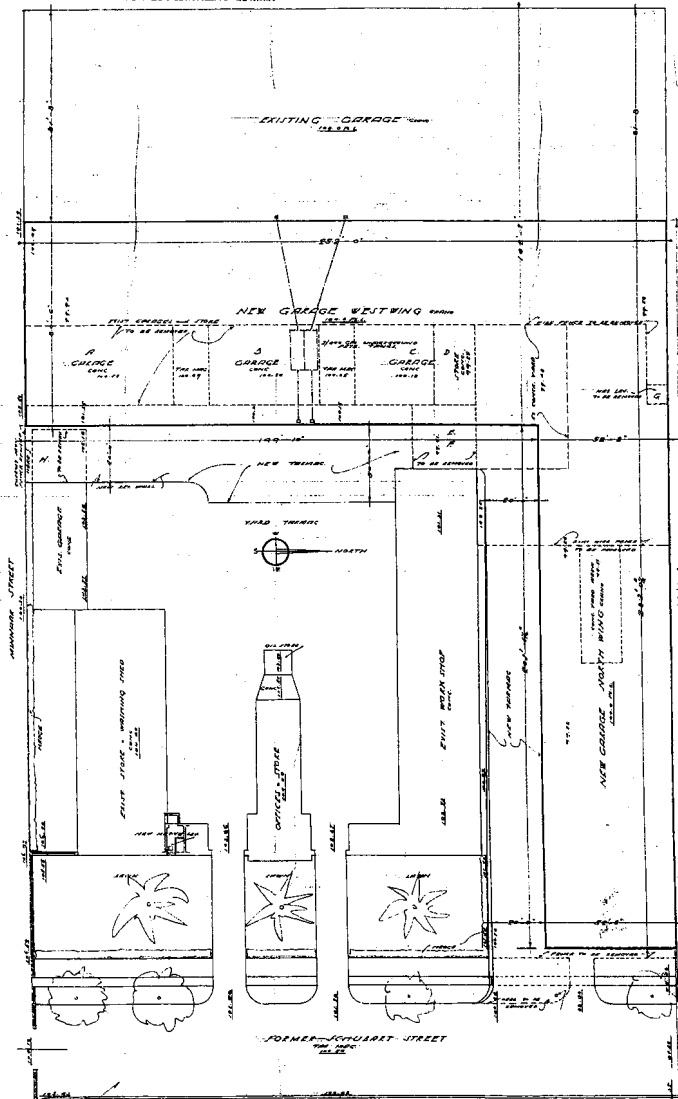

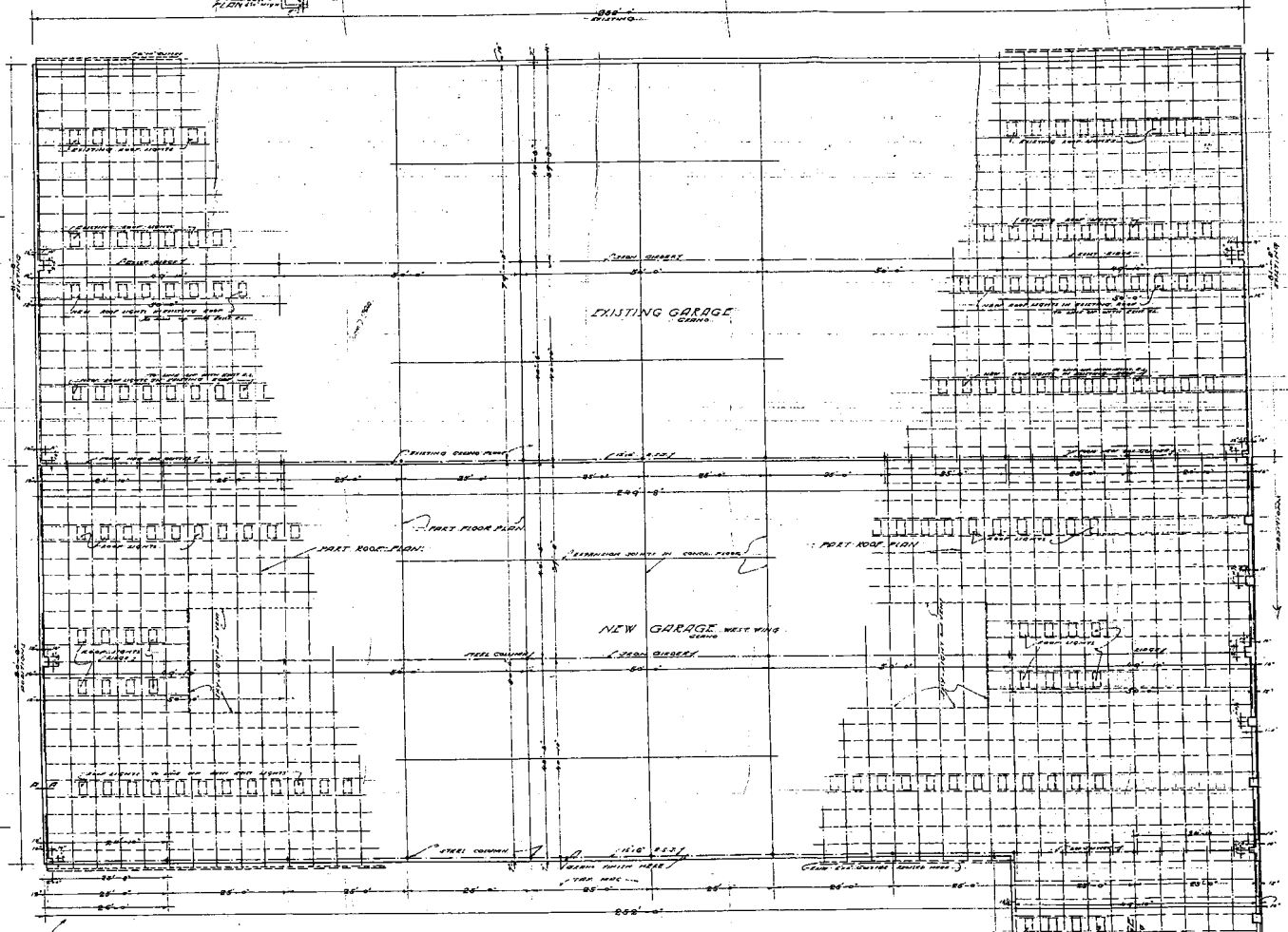
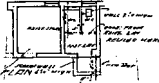

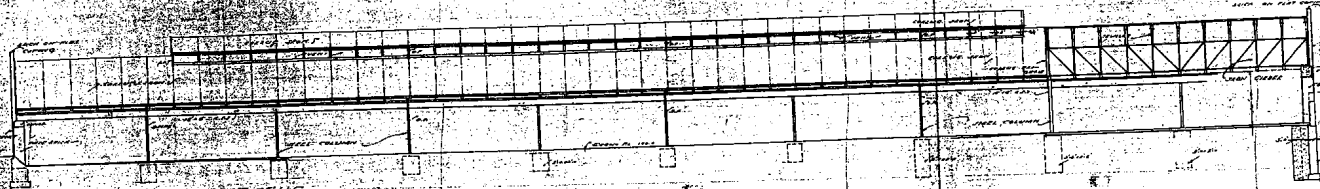
FLOOR PLAN

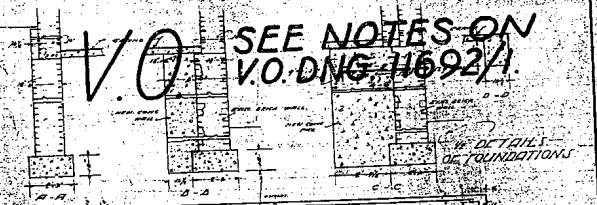

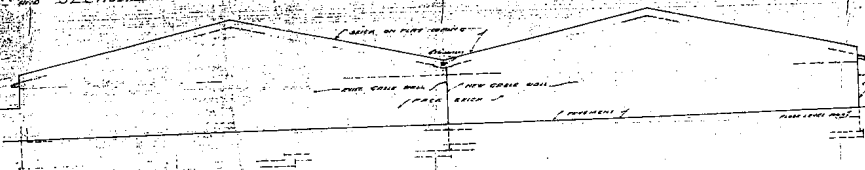

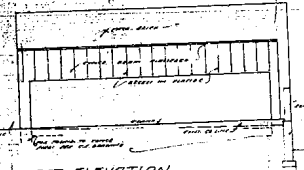
EAST ELEVATION WEST WING
SECTION A-D



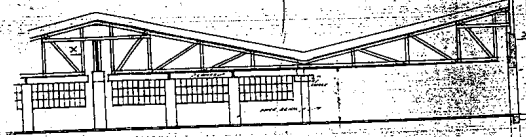
DETAILS OF FOUNDATIONS

THREE BAYS - MAIN WALL FACE



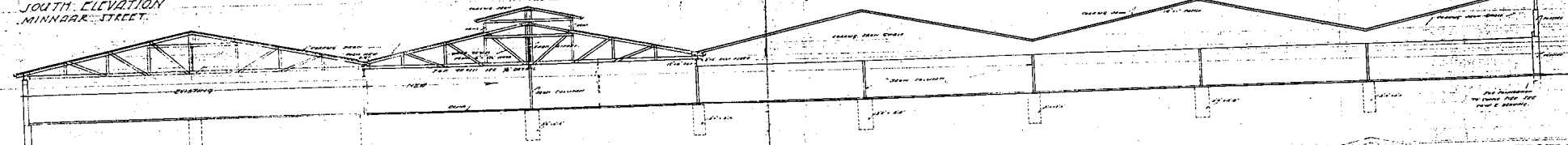
SOUTH ELEVATION

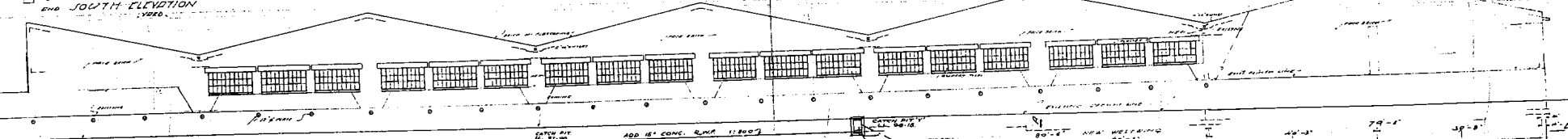
EAST ELEVATION
FORMER JOHUBERT STREET



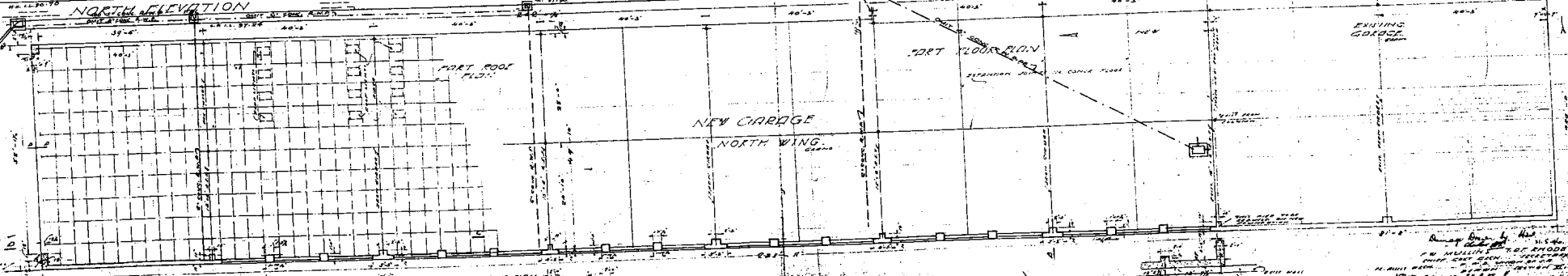
PART SECTION C-D
