Die proefskrif ondersoek die beskouingsverandering en voortspruitende juridiese hantering van persone met gestremdhede in die rigting van 'n toenemend inklusiewe en geïntegreerde openbare regssorde wat die beskerming en bevordering van die regte en belang van persone met gestremdhede op gelyke grondslag met alle ander persone bewerkstellig.

Gestremdheid word aan die hand van twee uiteenlopende modelle beoordeel en hanteer. Die twee modelle - die mediese en die sosiale model van gestremdheid - verteenwoordig twee uiteenlopende opvattinge oor gestremdheid wat in duidelik onderskeibare regsbenederings neerslag vind. Oor die afgelope

nagenoeg dertig jaar het die sosiale model beduidend veld teen die mediese model gewen. Dit het veral neerslag gevind in die internasionale reg, soos dit die afgelope dekades onder die aanvoering van die Verenigde Nasies in omvattende standaardisering en universalisering van menseregte ontwikkel het. Hierdie ontwikkelings word breedvoerig in hierdie proefskrif ondersoek. Die groeiende aanklank van die sosiale model ten koste van die mediese model is eweneens merkbaar in twee ander jurisdiksiegebiede, wat in hierdie werk ondersoek word naamlik Europa – binne die konteks van sowel die Europese Raad as die Europese Unie - en die Verenigde State van Amerika. In albei hierdie jurisdiksiegebiede weerspieël die ontplooiing van die positiewe reg 'n verandering in die beskouing oor die regshantering. Daarvolgens word gestremdheid toenemend volgens die sosiale model as 'n vorm van diversiteit eerder as uitsluitlik in terme van die mediese model verstaan. Gestremdheid vereis gevolglik 'n besondere regsbedeling ten einde daadwerklike gelyke beregtiging vir persone met gestremdhede te verseker eerder as (net) mediese ingryping as 'n "afwykende toestand" of 'n "siektetoestand." In hierdie studie word die veranderde regsbedeling oor gestremdheid deurlopend deur die prisma van die twee modelle beskryf en beoordeel.

Ten aanvang van die studie word die betekenis van die mediese en die sosiale modelle uitgeklaar. Daarna volg 'n bondige historiese oorsig, waarin oorheersende samelewingsbeskouings oor gestremdheid bespreek word. Dié historiese oorsig skets inderwaarheid die agtergrond waarteen die ontwikkeling in die hantering van persone met gestremdhede op die gebied van die reg beoordeel word. Sedert die Tweede Wêreldoorlog het 'n beduidende beskouingsverandering oor gestremdheid ingetree en ook in die positiewe reg

neerslag gevind. Dit word aan die hand van die vooraf-bespreekte modelle toegelig. Dit word gedoen deur die positiewe reg in sake gestremdheid in vier regsordes te bespreek: Eerstens, die ontplooiing van die internasionale reg oor gestremdheid, aan die hand van die werksaamhede van die Verenigde Nasies; tweedens, die ontwikkelings in Europa; derdens ontplooiing in die Verenigde State van Amerika. In die proses word die invloed wat die regsbedelings van die VSA, Europa en die internasionale reg op mekaar ook deurlopend toegelig.

Uiteindelik - vierdens - verskuif die fokus ook na 'n bespreking van die onlangse ontwikkelings oor die gestremdheidsreg in Suid-Afrika, kragtens die Handves van Regte binne die Suid-Afrikaanse grondwetlike bestel en onder die invloed van die internasionale reg.

Die studie sluit af met gevolgtrekkings. Daarin val die klem op 'n beoordeling van die verandering van die reg rakende gestremdheid in die lig van modelle wat in die eerste hoofstuk toegelig is.

This thesis investigates a perceptual change in and resultant new approach with regard to the juridical management of persons with disabilities aimed at a more inclusive and integrated public legal order with a view to the protection and promotion of the rights and interests of persons with disabilities on an equal footing with those of other persons.

Disability is dealt with and evaluated with reference to two opposing models. These models of disability – the medical and the social – represent two different notions about disability that find application in clearly distinguishable legal approaches. For about the past thirty years, the social model has gained considerable ground on the medical model. In international law in particular the social model has found application in the comprehensive standardisation and

universal acceptance of human rights, as developed over the past decades under the leadership of the United Nations. These developments are investigated in detail in this thesis. The growing acceptance of the social model as against the medical model is apparent in two other jurisdictions investigated in this work, namely Europe – within the context of the European Council and the European Union – and the United States of America. In both of these jurisdictions the changing views as to how the law should respond in order to meet changing demands regarding disability are reflected in the development of positive law. In terms of these divergent views disability is increasingly regarded, as a form of diversity, in accordance with the social model, in contrast with an exclusive medical model. Disability therefore requires a unique legal dispensation in order to ensure genuine equal treatment for persons with disabilities rather than a (mere) medical intervention in “deviate condition” or an “illness”. In this study the divergent legal dispensation regarding disability is continuously described and evaluated through the prism of these two models.

The study commences with an exposition of the meaning of the medical and social models. This is followed by a brief historical overview in which prevalent views on disability are discussed. This historical overview actually outlines the background against which the legal evolution on the management of persons with disabilities is judged. Since the Second World War a significant change in attitude towards disability has taken place and this also reflected in the positive law. This change is explored by way of the aforementioned models by discussing the positive law regarding disability in four legal jurisdictions: First, the evolution of international law regarding disability by way of the activities of the United Nations; second, the developments in Europe; third, the evolution in

the United States of America. In this process the mutual influence of the legal dispensations of the USA, Europe and international law is highlighted consistently.

Fourth, the focus shifts to a discussion of recent developments regarding disability law in South Africa in the light of the South African Bill of Rights and the influence of international law.

The study ends with conclusions in which the emphasis falls on an evaluation of the changes in the law on disability in light of the models that were expounded in the first chapter.
