

MISCELLANEOUS RECEIPTS.

*Under this head are classed several minor Receipts,
amongst which are the following:—*

1. Receipts in the Somerset Hospital.

These consist in sums paid by individuals for medical treatment, &c. in the hospital. The fixed rate of charge is 1s. 3d. per diem for all classes of patients, except Masters and the Chief Officers of Ships, who are charged 3s. per diem. The receipts are paid into the Colonial Treasury, from which the expenses of the institution are defrayed.

Reductions in the charges are, however, made in individual cases, according to the circumstances of the parties, and paupers are treated without charge, with the special sanction of Government in each case, or when sent to the hospital by the Superintendent of Police, or Police Surgeon, as nuisances to the community.



2. Rent.

For the hire of houses, islets, rocks, salt-pans, &c. the property of the crown.



3. Interest.

Payable on the amount due on lands, buildings, building allotments, &c. purchased from Government on credit, for different periods, and for which it is usual for the purchasers to pass mortgage bonds, bearing interest and payable by instalments.



4. Sale of Oakum.

A small sum is received from the sale of oakum, picked by the female prisoners, convicts, or others confined in the house of correction in Cape Town.



5. Market Dues.

The following charges are levied under authority of Proclamations of His Excellency the Governor, dated respectively 29th Aug. 1845, and issued in terms of Ordinance No. 6, 1837.

PERSONAL FEES.

Schedule of the Fees received by the several Officers in the respective Departments, specifying the authority under which they were originally established.

Magistrates' Courts.

The Clerks of these Courts (with the exception of Cape Town) and the respective Messengers are allowed to demand and enjoy the fees hereinafter mentioned.

Clerks of Court.

These, with the exception stated, acting as District Clerks to the Circuit Courts, are authorised to retain, for their own benefit, the following items of a Tariff of Fees directed to be charged for proceedings in Civil Cases in the Circuit Courts of the Colony, under certain Rules of Court, promulgated in Cape Town on the 24th January 1832.

These Fees were sanctioned by a Government Memorandum, bearing date 14th August 1832, as a remuneration to the Clerks, for extra duty, and are in addition to the stamps prescribed by the regulations on that head.

Messengers.

By the Rules and Regulations for the respective Magistrates' Courts, promulgated by the Lieutenant-Governor in Council on the 22d March 1828, the Messengers of those Courts are permitted to make the following charges in Civil Cases, and their fixed salaries are consequently on a low scale, being considered principally as a remuneration for the service of Summonses in Criminal Cases, in which their necessary horse-hire only is allowed,—the expenses being defrayed by the crown.

The Messengers are also allowed to charge horse-hire according to a fixed Tariff: most of them employ one or more deputies at their own expense.



Police Establishment.

The undermentioned Fees were authorised by the Colonial Government on the 12th October 1818, to be charged by the Officers and Constables of the Cape Town Police, and are divided amongs them in certain proportions.

Similar fees are enjoyed by the Police in the country districts, with some variations, arising from local circumstances or enactments of the late Boards of Landdrost and Heemraden, by which charges of this nature were mostly regulated before the extinction of those boards at the end of 1827.



Clerical Establishment.

Hereunder are inserted statements relative to the fees enjoyed by the officers of the English Episcopal and Dutch Reformed Churches of this Colony.

1. ENGLISH CHURCH.

The charges allowed to be made by the Chaplains, Clerks, and Sextons of the several English Churches were regulated by the Colonial Government in the year 1823, and are as follows:

By the same regulation, the Sexton is authorised to demand a fee of 7*s.* 6*d.* for each grave he may be required to prepare.

2. DUTCH CHURCH.

The perquisites enjoyed by the Clerks and Sextons of the several Dutch Churches in the Colony are not fixed by any Government Regulation, but consist principally in the free-will offerings of the community, on occasions of marriages, baptisms, and funerals. The rates consequently differ according to the circumstances of the parties; but have in most instances become settled by custom, although they may vary slightly in the several districts.

Under the Order of the Queen in Council, dated 7th Sept. 1838, an additional fee of 4*s.* is demandable for every marriage solemnized.



Port Office.

Under authority of the Ordinance No. 4, dated the 30th Jan. 1844, the following Tariff of Salvage is demandable by the Port Captains of the Ports of Cape Town, Simon's Town, and Port Elizabeth, for the recovery of Anchors or Cables parted with, and also for searching for the same.

For every Anchor or Cable having a Buoy attached there- *s. d.*
to,—for every British hundred-weight thereof, 5 0

For every Anchor or Cable not having a Buoy attached there-
to, there shall be payable in addition to the above rate, the
following further charges for the services of the Port Captain
and his crew, and for the use of the boat and tackle employed
in searching or sweeping for the same, viz:—

For the superintendence of the Port Captain for each day *s. d.*
so employed, 5 0

For each man of the crew, 2 6

For the use of the boat and Tackle, 10 0

But in no case shall the above daily charges be made for any greater period than three days, unless with the previous sanction of the Governor.

Witnesses attending Criminal Prosecutions.

The expenses are allowed to the necessary witnesses *summoned by the Crown* to give evidence on any criminal trial before the supreme court, or resident magistrates' courts, or at any preliminary examination before a resident magistrate or justice of the peace, excepting, in cases of common assault, trespass or verbal injuries, when no expenses are allowed.

Expenses are also allowed to the necessary witnesses *summoned by the prisoner, or party accused*, upon a certificate under the hand of the judge or magistrate who presides, that the prisoner is unable, from poverty, to pay such expenses.

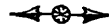
The expenses allowed are in no case to exceed 4s. 6d. per day, for subsistence and travelling expenses in going to and returning from the court, and during the necessary attendance there, or at the preliminary examination.

When the witness resides within 5 miles of the town or place wherein a trial is held, the allowance is not to exceed 3s. a day, but a witness residing within a town or place wherein any preliminary examination is held, shall not receive any allowance whatsoever for attending such examination.

Boat Hire.

There is no fixed tariff for boat-hire, but the charge usually made by commercial boatmen, for landing or shipping cargo, varies from 2s. 6d. to 3s. per ton.

The passage boats charge agreeably to time and circumstances, but 7s. 6d. seems to be the average for passages.

Stone ballast, 6s.—Sand ballast, 3s.—Water, 3s. per ton.

shall declare which side has the majority. Every Member present is required to give his vote on every division ; but it is competent to him, if he shall think fit, to record the reasons of his dissent from the opinion of the majority, at the bottom of the day's proceedings.

11. In discussing any Question, no Member shall be at liberty to speak more than once, except in explanation ; or, when any Bill is under discussion, clause by clause.

12. It shall not be competent for any Member to speak to any Question after the Council shall have begun to vote upon that Question.

13. An adjournment of the discussion may be moved by any Member.

14. Every Member shall, in discussing any Question, address the Chair, and shall stand while so doing ; and should he wish to allude to the speech or opinion of any other Member, he must do so without naming him. Official Members may be designated by their Appointments.

15. All imputation of improper motives shall be considered as being highly disorderly ; and such conduct shall be minuted on the Journals, if it shall appear to a majority of the Council to be necessary.

BILLS.

16. On a Bill being presented, the Clerk of the Council shall read the title thereof, but it shall be competent for any Member to require that the Bill shall be read at length, and, thereupon, the same shall be read accordingly.

17. Immediately after every Bill shall, in manner aforesaid, have been read a first time, it shall be competent for any Member to move that a day be appointed for considering the question of the second reading of the same, which motion having been seconded and carried, some future day, (which shall allow of the due publication of the said Bill, as hereinafter stated,) shall be appointed for considering the said question of the second reading of the said Bill.

18. When a day has been appointed, as in the preceding Rule mentioned, for the second reading of any Bill, the said Bill shall be printed as soon as possible, and the Clerk of the Council shall forthwith transmit a printed copy thereof to each of the Members of Council, and also cause it to be published in the next ensuing *Government Gazette*.

19. It shall not be competent to entertain the question of the second reading of any Bill, until the same shall have been published as before mentioned, twenty-one clear days in the *Government Gazette*. Provided, however, that the Council may, by its vote, determine in any particular case, that any certain Bill shall be published as aforesaid, but for some shorter period than twenty-one days, or not at all, as circumstances may seem to require.

20. Upon the day appointed for the consideration of the question of the second reading of any Bill, any Member may move that the same be read a second time ; which Motion having been carried, the Council shall thereupon proceed to discuss the several provisions of such Bill and all proposed Amendments, and may

To any person who shall bring paper to the Stamp Office in Cape Town, to be stamped, or who shall buy stamped paper at the said Stamp Office, the duties whereof shall amount to *Ten Pounds*, or upwards, an allowance after the rate of £10 for every *Hundred Pounds*, upon prompt payment of the said duty upon paper so bought or stamped.

Exemptions

*From the Duties on Papers containing Public News,
Intelligence, and Occurrences.*

Acts of parliament, orders in council, ordinances, proclamations, government minutes, and acts of state, or other matters printed by order of H.M. or of the government.

Any paper containing a single advertisement, printed and dispersed separately, save and except hand bills, as specified in the proclamation of the 10th Dec. 1824, Art. 6.

Daily accounts, or bills of goods imported and exported, and prices current.

STANDING RULES AND ORDERS

For maintaining Order and Method in the Despatch of Business in the Legislative Council.

1. One week's notice shall be given by way of publication in the *Government Gazette*, of every Sitting of Council, unless in cases of emergency, or when any Sitting is appointed to be holden by adjournment.

2. No Member shall absent himself from Council, without satisfying His Excellency the Governor of the necessity of such absence.

3. His Excellency the Governor, or, in his absence, the Presiding Member, shall preserve order, and decide on all disputed points of order.

4. As soon as six Members (exclusive of the Governor, or Member who is to preside) shall be present, after the hour appointed for the meeting of Council, the Governor, or, if His Excellency shall signify that he is prevented from attending, the Member, who is to preside in His Excellency's absence, shall take the Chair; and, Prayers having been first read, will direct the Clerk of the Council, in conformity with the Royal Instructions, to begin the Proceedings of the Day, by reading the Minutes of the Proceedings of the last Meeting of Council, which, having been approved, are to be confirmed by the President.

5. With the exception of Questions of Privilege, which shall take precedence of all others, all Business shall be taken in the order in which it appears in the "Order Book," unless by permission of the President, on good reasons being shown for such deviation.

6. Every Motion and Amendment must be in writing, and must be seconded before it can be put.

7. No Member shall be allowed to read any Speech.

8. In regard to the mode of putting Questions to the vote, in order to take the sense of the Council thereupon, the Council shall, in all cases not provided for by its own Rules, proceed, as much as may be, according to the practice of the House of Commons.

DISCUSSION.

9. If two or more Members rise to speak at the same time, the President shall call on the Person entitled, in his opinion, to pre-audience.

10. It shall be competent for any Member, upon being seconded, to divide the Council upon any Bill or Question; and upon such division taking place, as upon all other similar occasions, the Council is to proceed to vote, beginning with the Junior Member,—the Clerk of the Council minuting the Vote of each Member; after which, the Governor, or Presiding Member,

adjourn such discussions from time to time as occasion may require, or may refer the same to a Committee for their report thereon.

21. As soon as the several Provisions of the Bill shall have been fully considered, it shall be competent for any Member to move that the said Bill, if amended, shall be re-printed and published in the Government Gazette; but if no such Motion be made and agreed to, the Bill, as amended, shall stand for the third reading.

22. When any Bill has been ordered to be re-printed and published according to the preceding Rule, it shall not be read a third time until twenty-one days after such publication, unless, at the time of agreeing to such reprinting and publishing, the Council shall otherwise direct.

23. It shall be competent for any Member, at any time before the third reading of any Bill, to move that the consideration of the same be resumed for the purpose of amendment; and if such motion be seconded and carried, the Bill shall be further amended, as the Council shall see fit.

24. Any Member may move the third reading of a Bill.

25. No alteration shall take place on the third reading of a Bill, and the only question to be put shall be,—“That this Bill do now pass.”

26. After a Bill has been read a third time and so passed, it shall be submitted by the Clerk of the Council to the Governor, for His Excellency's consideration.

THE CLERK OF THE COUNCIL.

27. The Clerk of the Council shall keep an Order Book, in which shall be entered and numbered, in succession, the Subjects intended to be brought under discussion at each Sitting.

28. He shall read all matters brought before the Council: he shall keep a Journal of Proceedings, on which shall be entered, in the order of succession, all subjects brought before the Council, and shall number the Proceedings of each day as of one general number.

29. He shall attend and act at all Committees appointed by the Council.

COMMITTEES.

30. Every Committee shall be appointed by the Council; and every Committee so appointed shall have the right to elect their own Chairman.

31. All Reports of Committees appointed by the Council, shall be signed by the Chairman, or, in his absence, by the Senior Member thereof.

PETITIONS.

32. Every Member shall have the privilege of presenting any Petition addressed to the Council, and the Member presenting the same may call upon the Clerk to read it.

33. Any Member may move that any such Petition be received; which motion being seconded, the question shall be put; or any Member may move that such Petition be rejected.

34. When any Petition shall have been received, it shall be competent for any Member to make such motion, grounded thereupon, as he shall deem expedient.

EVIDENCE BEFORE COUNCIL AND COMMITTEES.

35. All Petitioners alleging that their individual rights or interests may be peculiarly affected by any Bill, may, by the leave of the Council, be heard, either in person or by Counsel, and may produce Witnesses.

36. Upon the examination of every Witness, whether before Council, or any Committee appointed by the same, his evidence shall be taken down by the Clerk of the Council, and read over to the Witness, who may then desire any correction to be made, and in case no such correction shall be made, such Evidence shall stand, and shall not afterwards be altered.

37. Counsel in attendance must be robed.

38. On the motion of any Member of the Council, that such Petitioner, Counsel, or Witnesses, do withdraw, they must withdraw as of course.

PRIVATE BILLS.

39. All other than general public Bills, must be drafted, printed, and published, at the expense of the parties whom it may concern, and in other respects proceeded with as in public Bills.

ADMISSION OF STRANGERS AND REPORTERS.

40. The Council allows the admission of Strangers and Reporters of the public Journals of the Colony, to be present at their Sittings.

41. In case it should be found, upon any occasion, that a greater number of Strangers should attend than the Council-room can accommodate, the Council shall make such arrangements, in regard to the mode of admitting a convenient number of Strangers, as they shall deem expedient.

42. All Persons admitted shall be bound to withdraw upon a motion made to that effect by any Member of Council.

When any Ordinance, which it is proposed to make the law of the colony, has been introduced into the Legislative Council, it is published in the Government Gazette, for the purpose of informing the inhabitants of the provisions of the intended ordinance, to enable such persons as may be so disposed, to make their observations for or against such proposed ordinance; and the ordinance must be published at least three weeks in the Government Gazette, before it can become the law of the colony.

When the proposed ordinance, thus introduced into the Legislative Council, and published in the Gazette, has *not* become the law of the colony, the title at the head thereof is, "*Draft of an Ordinance proposed by the Governor of the Cape of Good Hope to the Legislative Council thereof,*" and as long

as this title is at the head of the proposed ordinance, and the same is signed by the Clerk of the Legislative Council *only*, it is yet under consideration by the Council, and has *not* become the law of the colony.

When however, the title at the head of the ordinance is "ORDINANCE enacted by the Governor of the Cape of Good Hope, with the advice and consent of the Legislative Council thereof," and the same is numbered, and signed by the Governor, the Secretary to Government, and the Clerk of the Legislative Council, *then* the ordinance has become the law of the colony, and not before.

Erection of a Flag-Staff on Lion's Rump.

On the 1st September, 1821, a Flag-Staff was erected on the Lion's Rump, for the purpose of communicating with Ships entering Table Bay, by means of Captain MARRYAT's Code of Signals, now in general use in the Merchant Service.

Vessels approaching the Land have, therefore, only to make use of that Code, as directed, for the purpose of their conveying or receiving communications to or from the Signal Post on the Lion's Rump.

It is to be recollected, that at this Flag-staff a *Colonial Telegraph* is also in use; but no mistake can arise therefrom if the Ships in the offing pay attention to Capt. MARRYAT's Code, the Flags of which are entirely different from those of the Colonial Telegraph.

Port Instructions for Table Bay.

Should it be the intention of a Master of a Vessel to discharge or receive on board any considerable quantity of Merchandize, a Berth will be pointed out by the Port Captain as close to the Jetty, or other Landing-place, as the safety of the Vessel and other circumstances will admit. The Vessel must then be moored with *two Bower Anchors*, with an open Hawse to the Northward, and especial care taken not to overlay the Anchors of, or in any other way to give a foul Berth to, other Vessels.—Ships and Vessels touching for Water and Refreshments, may ride at single anchor in the outer Anchorage; and it is particularly recommended to veer out 70 to 80 fathoms Cable, as the chance of fouling or starting the Anchor, or breaking the Chain, will thereby be much lessened; if riding by a Hemp or Coir Cable, a Stream or Kedge should be laid out to steady the Vessel; and the other Bower Anchor should be kept in perfect readiness to let go. When a Vessel has been moored or anchored as aforesaid, (with Buoys and good Buoy Ropes,) the exact place of the Ship should be taken by Land Marks, and the depth of water; and should she drift from such situation, or lose her Anchors, the same must be notified in writing to the Port Captain. It is particularly recommended that Vessels be kept as snug as possible, as the periodical Winds blow occasionally with much violence. The sheet Anchor should be always ready for immediate use, and strict attention paid to keep the Hawse clear; the more so, when it is probable that the Wind may blow from the Northward.

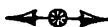

NOTICE TO MARINERS.



Royal Observatory.

 The Commanders of Ships, and others connected with the shipping interest, are informed—that a *Ball* has been erected at the flag-staff before the south front of the Observatory, for the purpose of daily communicating to the ships in the harbour, the instant of *one* o'clock Cape mean time, which corresponds to 11h. 46m. 5s. Greenwich mean time.

As the rate of a chronometer obtained on shore rarely agrees with the true rate at sea, (the motion of the ship and other causes producing the alteration,) it becomes necessary to ascertain the sea-rate after the chronometer has been placed on board in the berth it is to occupy during the voyage, and from which, on no account, it should be removed throughout that period.

The present contrivance furnishes a convenient method for obtaining this important object, without any calculation or difficulty. All that the observer has to do is, to point the common ship spy-glass to the signal ball a minute or two before *one* o'clock, and to note the instant of the fall of the ball from the top of the staff, by chronometer; then 11h. 46m. 5s. subtracted from the time by chronometer, it gives the error of the chronometer, or Greenwich mean time, which, compared with the error obtained at departure, will give the rate during the interval.

When the vessel continues a week or ten days in the harbour, it will be satisfactory to know the existing rate. If the rate should be trifling, perhaps less than the probable errors of observation, it will be right to diminish the latter by dividing the observations into two or more groups, and to take the mean of each group for one observation, the differences of these means, divided by the intervals of days, will give a determination very close to truth.

Ships or Vessels, having MARRYAT'S Code of Signals, can make their wishes known to their Agents, in blowing weather, through the Port Office ; and any assistance required will be strictly attended to, as far as practicable. Vessels not having the Code, can make the following with their Ensigns :—

1st. *Ensign in the Fore Top-mast Rigging.*—I am in want of a Cable.

2d. *Ensign in the Main Top-mast Rigging.*—I am in want of an Anchor.

3d. *Ensign in the Fore Rigging.*—I have parted a Bower Cable.

4th. *Ensign in the Main Rigging.*—I am in want of an Anchor and Cable.

5th. *Whift, where best seen.*—Send off a Boat.

Instructions for entering Table Bay by Night.

*By the Plan constructed on the Observations made by H. M. Ship
"Leven," Nov. 1825.*

(THE BEARINGS ARE ALL BY COMPASS, OR MAGNETIC.)

1. To enter Table-bay from the northward, meaning to pass outside of Robben Island, a ship should keep the light to the eastward of south—9 degrees east, or about south and by east, until she gets soundings under 20 fathoms, at a little more than a mile from the light house, she may then steer east south-east, or east and by south, not to come under 10 or 12 fathoms until the light bears west south-west ; she may then steer for the anchorage, and may anchor in from *seven to six* fathoms, as soon as the lights are shutting in behind the Lion's Tail.

This track leads about a mile clear of danger on Greenpoint, but a ship need not approach it so near, if she have, by seeing Robben Island, ascertained by its bearings that she is clear of the Whale Rock, in which case she may round it at a greater distance from Green-point, if desirable, but the soundings, in that case, will not alone be a sure guide.

2. In coming from the south-west, a ship should not get less than forty fathoms, before the light bears south-east, or east south-east, nor less than twenty fathoms, before it bears south and by east, when the preceding directions may be followed.

From the northward—inside of Robben Island—the light should be kept about south-west by south, until a ship have passed that island ; in doing which she may have some casts from eight to six fathoms ; and when on that course the water deepens to eleven or twelve fathoms, she may steer for the anchorage by the plan as before directed.

In beating round Green-point, a ship should never shoal her water under eleven or twelve fathoms, until she have brought the light to bear west south-west, as before said.
