Straf ligter ná 'seksistiese argument' Verkragter kry nie lewenslank omdat vrou dit 'goed hanteer'

Kaapstad. 'n Verkragter het verlede week die vereiste lewenslange tronkstraf vrygespring omdat die regter se uitspraak op 'n "totaal seksistiese argument" berus het, meen 'n Stellenbosse hoogleraar in politieke wetenskap.

Die feit dat die verkragte vrou haar trauma "baasgeraak" het en dat "onnodige" geweld nie tydens die **verkragting** gebruik is nie, is deur waarnemende regter Lee Bozalek genoem as redes waarom hy van die voorgeskrewe vonnis afgewyk het.

Hy het Godfrey Monwabisi (32) eindelijk vir 18 jaar tronk toe gestuur. Monwabisi is vroeër daaraan skuldig bevind dat hy die klaagster twee keer binne 45 minute verkrag het.

Prof. Amanda Gouws, een van die land se voorste kampvegters vir vroueregte, het gister skerp te velde getrek teen die uitspraak van Bozalek in die Kaapstadse hooggeregshof.

Die regter het as redes vir die ligter vonnis aangevoer dat die slagoffer haar trauma relatief goed baasgeraak het. Hy het ook in sy uitspraak gesê die **verkragting** was "geensins een van die ergste nie".

"Jy het dit gelukkig getref dat die slagoffers wat jy gekies het, taaier en meer aanpasbaar as ander is," het Bozalek dit aan Monwabisi gestel. Volgens Gouws toon die uitspraak 'n totale gebrek aan insig oor die trauma van **verkragting**. Dié trauma kan baie keer jare ná die **verkragting** eers te voorskyn kom, het sy verduidelik.

In 'n land wat een van die hoogste verkragtingsyfers ter wêreld het, behoort 'n regter die wet toe te pas soos wat dit toegepas behoort te word, het Gouws gesê. Volgens haar hou Bozalek se argument oor die gebrek van onnodige geweld ook nie steek nie, want dit sou beteken dat **verkragting** later net voorvalle van ernstige geweld sal insluit. "Sy uitspraak berus op totaal seksistiese argumente," het Gouws gesê.

RESEARCHER

- **Who is the researcher and who are the mentors in this project?**

Ms. Kruger, a registered educational psychologist is the researcher. The mentors are Professor dr Kobus Maree, attached to the Department of Educational Guidance and Counseling and Dr Rina Delpont, attached to the Department of Social Work at the University of Pretoria.

- **Will the respondent be required to discuss with other persons not involved with the research project?**

No.

- **What experience does the researcher have?**

Ms. Kruger is an educational psychologist who has already dealt with victims of sexual abuse and is conversant with therapy to children and adolescents.

NATURE OF THE STUDY

- **What is the purpose of this study?**

The aim is to make a meaningful contribution in the field of narrative therapy. Although individuals are the experts of their own lives it is equally true that the stories of peoples' lives have a mutual influence. In this study the idea is to establish whether previous victims of sexual abuse, who have successfully integrated the incident(s) in their own lives can be of support to others in similar circumstances to assist them in the reconstruction of their lives.

- **What will the respondents be required to do?**

Respondents will be asked from time to time to communicate with one another – in writing – to give the others an insight into how they are coping whilst trying to work through their own trauma. Writers can remain anonymous or may use pseudonyms. Respondents will also be asked whether the researcher may use their life story in order to help other victims of sexual abuse.

- **Will misleading be used? If so, why is it necessary?**

Misleading will only be used where the identifiable details of a victim are involved.

- **Are there any physical, psychological, judicial or social risks attached to my participation?**

No. Respondents may withdraw at any time without having to present any reasons.

RESEARCH PARTICIPANTS

- **How is the canvassing of respondents handled? Is there any remuneration involved?**

All respondents who attend ms. Kruger's private practice for therapy and/or guidance and who fit the requirements will be asked to take part in the project.
