# A Cytoscape app for motif enumeration with ISMAGS

#### Abstract

**Summary:** We present a Cytoscape app for the ISMAGS algorithm, which can enumerate all instances of a motif in a graph, making optimal use of the motif's symmetries to make the search more efficient. The Cytoscape app provides a handy interface for this algorithm, which allows more efficient network analysis.

# 1 Introduction

Network motifs are small subgraphs which are overrepresented in an explored graph, compared to what would be expected statistically. The function of a graph is reflected in which motifs occur more often and which nodes make up these motifs (Milo *et al.*, 2002). In particular, motifs in protein–protein interaction networks and transcription regulatory networks correspond to cell functions (Grochow and Kellis, 2007). Therefore, these motifs are a powerful tool to analyze graphs. Moreover, the motifs have an ordered structure which can be divided in clusters, giving more detailed information about the nodes' function compared to classical clustering (Benson *et al.*, 2016). Many algorithms to enumerate them exist (Grochow and Kellis, 2007; Omidi *et al.*, 2009; Wernicke and Rasche, 2006, etc.) including a GPU-based method (Lin *et al.* (2015)). In this work, we focus on an application which can be run on a standard, off-the-shelf desktop or laptop without specialized

hardware. ISMAGS (Houbraken *et al.*, 2014) is an efficient Java implementation for the motif enumeration problem running on stock hardware.

When we talk about enumerating all instances of a certain motif, we mean finding every subgraph that is isomorphic to the given motif within an explored graph. These subgraphs will be called *motif instances*. Motifs are not *induced* subgraphs, which means nodes in motif instances may be connected by edges not in the original motif. As not all edges are known in biological networks, this is a useful approach. Between any pair of nodes in a found motif may, indeed, be unobserved edges. If any of these edges are found, the motif instance will still be valid.

Here, we first describe ISMAGS shortly, then we present the features of a new ISMAGS Cytoscape app. This app has all features of ISMAGS, is completely compatible with Cytoscape networks and accepts several formats for input of motifs. The visual interface makes the motif search easier, and it allows the user to efficiently use the results and gain insight in the connections between different motifs in a straightforward way.

# 2 ISMAGS: optimized motif enumeration

ISMAGS (the Index-based Subgraph Matching Algorithm with General Symmetries) is an efficient algorithm to enumerate all instances of a motif within a graph. It makes optimal use of a motif's symmetries to eliminate as much of the search space as quickly as possible.

Before the search, the motif's symmetry is analyzed. First, its automorphisms are found and the nodes are divided into automorphism orbits. These automorphisms are permutations of the nodes which leave the edge set unchanged, and orbits are the sets of nodes which can be mapped onto each other by these automorphisms. From the automorphisms, stabilizers are derived. These are sets of automorphisms which do not change the first *n* nodes of the motif, one set for each additional node. This means the first stabilizer is the set of automorphisms that keep one node unchanged. The permutations in the second set keep that node and another one unchanged and the last set only contains the identity permutation. Each stabilizer is a subset of the previous one, forming a stabilizer chain. In each stabilizer in a chain, the nodes which are not yet stabilized can still be mapped on a number of other nodes. The set of nodes a certain node can still be mapped to, just before it is stabilized, is called that node's coset representative. These coset representatives are used to impose symmetry-breaking constraints on the nodes of a motif instance. These constraints are imposed as an ordering of each node's unique index. This eliminates the possibility of finding different motif instances with the same graph nodes, which decreases the running time of the algorithm. More detailed information can be found in Houbraken et al. (2014).

When the motif's symmetries are known, the search can begin. The motif is built by adding nodes to a motif instance, mapping graph nodes to motif nodes. Each time a new node needs to be mapped, the motif node to which the least graph nodes can be mapped is chosen to cut down the search tree as much as possible, as quickly as possible. Specialized data structures, such as checklists for mapped nodes and iterators for each motif node's candidate mappings, ensure the algorithm is iterative. For more information, see Demeyer *et al.* (2013).

ISMAGS can handle edges of different types, both directed and undirected, within one graph. ISMAGS is a very flexible tool and accepts many different types of networks.

# **3 Implementation**




Fig. 1. The ISMAGS-Cytoscape interface. The interface features are marked in red

When using Cytoscape with the ISMAGS app, a new tab appears in the control panel, named ISMAGS. Here, the network in which the motif must be searched and the motif itself must be selected from two drop-down menus. Any opened Cytoscape network may be selected for either of them. ISMAGS is fully compatible with Cytoscape networks, both for motif and search network. Additionally, motifs can also be defined by their string form, as is done in ISMAGS following an encoding scheme introduced in Demeyer *et al.* (2013). When a network is selected in the motif selection menu, its string form appears in the text box below. Changes in the string form will show in the network and vice versa (Fig. 1).

Upon selecting the motif network, the different motif edge types appear in the edge table in the left panel. This table lets the user edit how the symbols from the motif string form map to the interactions in the motif network. An edge type can be set to be undirected, which will ignore its direction while searching for motif instances. Also, the color of the edge types can be changed.

Search results are shown in the Results Panel on the right. The panel shows a brief summary of the run: the motif, the number of found instances and the runtime of the algorithm. The results table lists every found instance of the motif. Selecting one or more instances will highlight the corresponding nodes in the network. Edges and nodes not part of any motif will be faded so they do not obscure the view of the motif instances. This allows for easy visual inspection of the motifs' position within the network, which may show patterns that are not obvious when using text results. With the built-in features of Cytoscape, the resulting subnetwork can then be exported and explored further, allowing for efficient subsequent analysis without needing to switch programs. The result set can also be saved in a format compatible with ISMAGS.

#### 4 Usage

Motifs are used in a wide variety of fields where network analysis is useful. Our ISMAGSapplication allows researchers to find significant motifs in reasonably large networks, and thus support and facilitate other highly-relevant research. In computational biology, motifs may correspond to cellular transcription machinery or cell-cycle regulation (Grochow and Kellis, 2007) and may be used to predict regulatory modules (Zhang *et al.*, 2008)). Also, motifs can be clustered intelligently, yielding new information about the nodes' function (Benson *et al.*, 2016).

#### 4.1 Runtime

To assess the application's running time, a number of motifs were searched in random graphs. As extensive runtime benchmarks of the ISMAGS algorithm can be found in Houbraken *et al.* (2014) we focus here on benchmarking the Cytoscape app itself. All of these tests were performed on a computer with 4 Intel<sup>®</sup> Core<sup>™</sup> i5-3230M CPU @ 2.60 GHz CPUs and 7.7 GiB internal memory.

A first test searches motifs in a random graph with 100 nodes and 1000 edges. These motifs were all undirected *n*-node star motifs, i.e. motifs consisting of one node connected with all n - 1 other nodes, which do not need to have any other edges amongst themselves. The result can be seen in Table 1.

While the running time rises quickly, so does the number of found instances. Motifs that appear more rarely, like clique motifs, are found more quickly. Cliques are motifs in which all nodes are connected. ISMAGS's performance for these motifs can be seen in Table 2.

Finally, in Tables 3 and 4, the running time of ISMAGS in networks of different sizes can be seen. In Table 3, a star motif was searched in networks with a fixed number of nodes but variable number of edges; in Table 4, the same motif was searched in networks with a variable number of nodes but fixed proportion of edges to nodes. Cytoscape save files for all of these tests can be found in the supplementary materials.

# **5** Conclusion

We have presented the ISMAGS app for Cytoscape, which can quickly and efficiently list all instances of a given motif in a graph. The clear interface offers all available functions in a straightforward layout. The visual output helps understanding the search results' meaning. The Cytoscape integration allows the use of a variety of networks and efficient export and use of the results. The combination of these features makes the entire motif searching procedure intuitive to apply, efficient and easy to interpret, supporting new research.
