I am writing on behalf of the University of Pretoria to request permission to **deposit electronic copies of articles published in your journal and authored by our institution's staff in our institutional repository**, UPSPace <http://repository.up.ac.za/>. Our senate has approved a policy of mandatory submission of research articles (<http://www.library.up.ac.za/openup/mandates.htm>) and I need to communicate your policy to our UP authors.

These articles will be deposited in Research articles collections which consist of the post-publication versions of academic research articles. It is a non-profit service, designed to showcase and collect together the work of academics at this university, and no charge is made for the use of any of the material deposited there. If we are permitted to deposit a copy of this research there, we propose to provide acknowledgment of your organisation and journal as the source of the article. We will also create a permanent link to your web page, if available.

If possible, it is preferred to **archive the finalized PDF version** as it appears in print as this version has an advantage over mounting the author's own version, in that it maintains consistency in appearance of the article wherever it is read. This also maintains a closer association of the article with the journal, through the header-title and journal house-style. However, if you require it, permission for the author to submit his/her/their final corrected, but unformatted version would also be acceptable.

The following article by a University of Pretoria author was published in your journal:

I will be grateful if you could contact me to give your permission for **including this article as well as future articles published by UP authors in your journal**, and to pass on any associated conditions.
