
I qualified as a Veterinary Nurse in 1986. I spent some time at home with my parents, after which I moved to Johannesburg and started working in February 1987.

As always, this year promises to be an exciting and busy one regarding Veterinary Nursing. Already, a few important issues required attention:

1. Epaulettes: This has become a very thorny issue. The SAVC has recently decided to hand over the administration of Vet. Nursing epaulettes to the VNasa. This decision caused quite a few problems for us, the most important being rectifying the situation which arose when the nurses that qualified in 1993 were issued with incomplete sets of epaulettes. I am still in discussion with the SAVC, but the matter should soon be resolved. The administration of epaulettes will in future be done by the VNasa and all inquiries must go to the treasurer, please.
2. Curriculum of Vet. Nurses: The comprehensive investigation by the SAVC of the curriculum has reached the stage where a document setting the minimum standards has been drafted and circulated to the relevant bodies. We have studies this intently and are currently drafting our recommendations. More about this at a later stage.
3. Examination for registration as a Vet. Nurse: The SAVC formed an Ad hoc committee to review standards pertaining to examinations written by persons qualified in countries other than South Africa which will entitle them to register as Veterinary Nurses in this country. We regard this as a very positive step to maintain the very high standard of our profession and are busy studying the document in order to comment on it, as requested by the SAVC.

Bogenoemde is enkele sake wat reeds aandag moes geniet.




To all the new council members good luck, and thank you for all the time and effort you will be putting into the association in the next few years.



Constitutional Changes

The following constitutional changes were accepted by the members at the symposium. The changes will be submitted to a lawyer to be rewritten with the correct legal wording.

Associate Membership

- Any person who is not qualified as a Veterinary Nurse, but who has a similar qualification, and who has an interest in becoming a member of the association.
- The associate member shall pay 50% of the full membership fee as set for that year.
- The associate member shall not hold voting rights.
- The council shall reserve the right to approve any proposed associate member.

AGM Minutes/Council Members/Other changes

- All AGM minutes are to be completed, ready for printing not later than three months after the AGM.
- Any member resigning from council shall be required to attend the next council meeting after the date of their resignation.
- There shall no longer be any restrictions on the length of time any one person can stand on council. (previously a council member was only allowed to stand for two consecutive terms).
- The constitution shall include a description of each council members position and responsibilities, to avoid any future confusion.
- A paragraph shall be included in the associations objectives that states that the VNasa is committed to opening the profession to both sexes and all races, colours and creeds.

New Council Structure

- Treasurer, Editor and PRO are to remain the same.
- Vice-President - a Vice-President shall be elected by the members at the AGM, and will stand for one year. They will automatically take over the position of President for the second year. The Vice-President will take over the responsibilities of the Secretary.
- President - the President shall serve for one year and shall then automatically become Senior Vice-President.
- Senior Vice-President - the Senior Vice-President shall serve for one year as an advisor to the President.

Changing The Face of Veterinary Practice

Extracts from a BSAVA News magazine article.

The role of the Veterinary Nurse as “pet health counsellors” was discussed at a course given at Grantham, England for British Veterinary Nurses.

The nurses role as pet health counsellors would be to improve the services their practice offered to clients and to release the veterinary surgeon’s time by performing those jobs for which they were trained as veterinary nurses. They would be able to help break down the barriers between clients and those in practice, to make the practice a less intimidating place - it will be somewhere clients can pop in for advice as well as treatment. “A friendly practice will be recommended to others.”

They went on to discuss communication skills. The veterinary nurse must try to see a situation through the client’s eyes. She should learn to use everyday words with which the clients were familiar. Simple words that the clients could relate to might include “bleeding” instead of “haemorrhage” and instead of “enzyme” they could try to explain it as a “chemical scissor”.

Conflicting opinions raised in the discussion showed the importance of developing a practice policy on issues such as when to spay and when to allow puppies to socialise with other dogs. Such policies would ensure that clients did not receive contradictory messages from within the practice.

Handling people is never more important than when euthanasia is involved. Some practical advice was given by Laura Lee, co-writer of the book “Absent Friend”. Clients should be told what to expect during euthanasia. If they are unprepared for the involuntary movements sometimes associated with the procedure, they may construe these as pain and will consequently be much more distressed. It is also best to keep the time they have to wait with other clients to a minimum. In some cases, a cup of tea and plenty of sympathy following euthanasia, will go a long way to reducing grief.

Often the most distressing aspect is having to pay the bill afterwards. Clients may appreciate paying beforehand or having the opportunity to pay later by post.

Behaviour problems in dogs are much easier to prevent than to cure. They quoted 33% of owners that wanted their dogs rehomed, cited their reason as being a behavioural problem with their dog or dogs. These problems were mainly put down to inadequate socialisation of puppies at an early age. The puppies were said to be most receptive to new experiences at six to sixteen weeks of age. The veterinary nurse should be able to advise the client on how best to go about socialising their new pet without endangering its health when the puppy has not yet developed a strong immune system.

At this course, the nurses were told how to initiate what is known as a “Puppy Party”. This has to be carried out under strict supervision of the veterinarian. He would give each puppy a clean bill of health and make sure it has had the vaccinations necessary for its age. Small groups would be held at a time, and this opportunity could be used for the nurses to demonstrate dog grooming, simple health checks to be done at home by the owner, and basic dental care. The importance of regular check-ups, vaccination programs, when to spay or neuter, etc. could also be discussed during this meeting. Obviously the suitability of “Puppy Parties” must be weighed up by the veterinarian for his practice.

The course also discussed the possibilities of “Obesity clinics” to advise on and measure the efficacy of weight loss programs for the over-weight pet, and “Geriatric clinics” to counsel the owner on special care for the older pet.

These clinics are not always practical to have, depending on the type and situation of your practice. It is none the less a fact that the veterinary nurse plays a large role in the education of, and general communication with the pet owner.

'n Hand Vol Vere

In verskeie spesiaal ingerigte vertrekke in Philip en Emsie Mohr se huis is daar geveerde op pad na die een of ander vorm van hersel. En hulle is nie troeteldiere nie. Die algemeenste mossie tot die skaarste valksoorte kry ewe veel aandag van Emsie.

Ons loop agter haar aan na die "hospitaalkamer", want soos in enige intensiewe sorgenoefenis, verg die voëlpasiëntjies deurentyd aandag en behandeling.

"Ek moet net gou die klein bergkanaries voer," sê Emsie. Die hoephoep moet ook aandag kry - "hy moet kortkort vloeistowwe inkry. En dan sal die janfiskaal wat ek vrygelaat het, ook nog netnou kom skree vir sy kos."

Die getal wissel soms van dag tot dag, maar op daardie stadium het Emsie 'n hele 70 voëls in haar sorg! Sonder haar man, Philip, en haar "regterhand", Anna Makwela, sou haar taak waarskynlik onbegonne gewees het.

Aan die hospitaaldeel van die huis is 'n ruim hok waarin nog voëls rondfladder en sy verduidelik dat dit die vrylatingshok is: 'n tussenstadium vir dié wat herstel het, maar geleidelik weer aan vryheid gewoond gemaak word. "Voordat 'n voël vrygelaat kan word, moet alles reg wees: hy moet byvoorbeeld gesonde vere hê." Emsie se mikpunt is nooit om die voëls mak te maak of by haar te hou nie. Perdfris terug na die natuur is die hoofdoel.

Talle voëls wat in haar sorg onverwags nie die paal haal nie (of uitgesit

móét word), kry 'n post mortem... want só leer sy al hoe meer hoe om die wesentjies te help. Alles word neergeskryf, en uit elke nadoodse verslag iets geleer.

Emsie kry professionele hulp en raad by kundiges, en iemand wat eenkeer 'n voël gebring het,leen haar 'n mikroskoop. Sy kan nou in beperkte mate inwendige parasiete en sekere bakteriese infeksies identifiseer.

Een van die wonderlike belonings wat Emsie vir haar liefdestaan kry, is dat van die gesonde, vrygelate voëls haar dikwels weer kom opsoek. Sy wag eintlik altyd in spanning daarvoor - want dan is dit gewoonlik 'n teken dat hulle weer hul voete gevind het. Hulle kom sit op haar skouer, of eet uit haar hand...of kom sommer dagsê.

In haar tuin is daar hope natuurlike voëlkos: eugenias, feijoas, kei-appels, waterbessies, druwe. En geen gif word ooit gebruik nie. Boonop is skuling volop in die bos-tuin, waarin onder meer dertig geelhoutbome staan.

'n Baba glasogie wat in die "waakeenheid" is, moet nou kos kry. Avokadopeer en meelworms - wat sy met 'n vurk fynmaak. Sy wys die bak krioelende meelworms wat sy self vir die voëls teel.

Gedagtes wat Emsie al neergepen het, geïnspireer deur haar "voëldoenery", saam met unieke foto's wat sy so deur die jare van die voëltjies geneem het, sal hopelik binnekort in boekvorm verskyn. Sy noem dit eenvoudig:

DIS NIE SÓ MOELIK OM 'N WILDE VOËL TE HELP NIE ...'N PAAR WENKE:

- Vir 'n voel wat stres het - byvoorbeeld wanneer hy raakgery is - is vloeistowwe belangrik: gee heuningwater, indien moontlik. Een teelepel heuning in 'n halwe koppie water. Nooit yskoud nie, kamertemperatuur of lou.
- As 'n voël weens stres sukkel om kos of vloeistof in te neem, kan dit op die bek gedrup word met heen-en-weer bewegings teen die snawel wat hom sal laat besef hy moet sy bek oopmaak.
- As 'n mens nie dadelik 'n voël kan uitkiek nie, is rou eiergeel (verkieslik verdun met 'n druppel heuningwater) altyd veilig. Of roereier (goed gaar en sonder sout). Daarby kan daagliks 'n druppel vitaminestroop (sommer dié wat geskik is vir kinders) gegee word, maar nie langer as drie dae ná mekaar nie.
- Vrugte-eters sal geesdriftig wees oor suiwer vrugtesap sonder suiker, of selfs babakos-in-'n-botteltjie. Onthou, vrugte-eters het ook proteïne nodig, en inseketers het ook vitamine C nodig.

- Varsheid en higiëne is belangrik, veral as maalvleis gevoer word.
- MOENIE melk, brood of gekoude kos aan babavoëltjies gee nie.
- MOENIE watte in die slaapplek gebruik nie - dit kom in die longe. Gebruik eerder 'n papierhanddoek of sage materiaal. Maar sit vir babavoëls growwe materiaal in vir vastrapplek.
- Hitte is belangrik, maar toets eers of die voël hitte nodig het deur dit op jou hand te hou. Jy sal voel as hy koud is. As 'n leeslamp van bo, of 'n warmwatersak of hittekussing onder die kartondoos (met ventilasiegaatjies) gesit word, moet daar darem ruimte wees vir die voël om daarvan weg te beweeg. Oppas vir te warm.
- Wilde voëls kan seerkry in 'n voëlhokkie - gebruik eerder 'n kartondoos met 'n oondrak of so iets bo-op, na gelang van die voël se grootte.
- 'n Telefoonoproep na die veearts of 'n kundige kan baie help! As 'n voël enigsins siek lyk, is onmiddellike aandag en behandeling noodsaaklik. (En terloops: bring 'n mens 'n voël na die veearts, onthou gerus dat hy beter daaraan toe is in 'n skoendoos met ventilasiegaatjies en 'n deksel wat stewig sit, as in 'n kou.)
- Weldoeners moet in gedagte hou dat, streng gesproke, 'n permit van Natuurbewaring nodig is vir die aanhou van voëls, sou hulle nie onmiddellik vrygelaat kon word nie.

Cancer In Geriatric Dogs

Cancer can occur in dogs of any age but is more common in older animals. Vaccination against infectious diseases, antibiotic therapy and safer anaesthetic methods have ensured longer lives for dogs, and, consequently, made it more likely that they will develop cancer.

By identifying patients at risk for cancer, teaching your clients to recognize the early warning signs, and making cancer evaluation a regular part of consultations of older dogs, the risk of cancer can be reduced or the chances for successful therapy be improved.

The frequency of tumors in dogs

In a California survey of more than 30 000 animals with spontaneous neoplasms, the skin and subcutaneous connective tissue were identified as the most common sites of neoplasia in dogs. When only female dogs were considered, the number of mammary tumors exceeded the number of skin and connective tissue. If epidermoid and basal cell carcinomas caused by wind exposure in people are excluded, dogs develop cancer more often than people do.

The effects of age

The incidence of neoplasia increases as dogs age. The cells of older dogs have undergone more cell cycles and have been exposed to carcinogens for a longer time than have the cells of younger dogs. As in women, most mammary tumors in female dogs occur in the older group, although some also occur in the middle-aged group. Among the most common tumors of young dogs are histiocytomas and skin papillomas, which are seldom seen in older animals. Lymphoma and osteosarcoma are frequent in elderly dogs, but also occur in young dogs. Interstitial cell tumors of the testicle are frequently found during postmortem examination of old dogs.

The effects of breed, genetics and sex

Longevity is related to breed. Giant breeds such as Great Danes and Irish Wolfhounds are considered old at seven to eight years of age, whereas the longer-living, smaller breeds would only be considered middle-aged at that age.

Boxers are at increased risk for many tumors such as sarcomas, lymphomas, mastocytomas, chemodectomas, glial tumors, testicular tumors, thyroid tumors, and hepatoid tumors of the anus (perianal adenomas). The giant breeds, including the Saint Bernard, Great Dane, Irish Wolfhound, Great Pyrenees, and Rottweiler, have a high incidence of osteosarcomas, a condition very rare in the toy breeds. Intermediate-sized breeds, such as the Labrador Retriever and Springer Spaniel, have a higher incidence of bone tumors than the toy breeds but a lower incidence than the giant breeds.

Dachshunds and Cocker Spaniels appear to be at increased risk for mammary tumors, while Chihuahuas are at considerably reduced risk for this type of cancer. Beagles, which have been the subjects of many toxicologic studies of hormones used in human oral contraceptives, have a risk for mammary tumors only slightly higher than the mean risk for all dog breeds.

Boxers, Basset Hounds, Saint Bernards, Airedales, and Bulldogs are at high risk for lymphoma. At high risk for testicular neoplasms are Boxers (all tumor types), Weimaraners and Shetland Sheepdogs (Sertoli cell tumors), and German Shepherds (seminomas).

The risk of thyroid tumors rises in dogs over six years of age. Boxers, Beagles, and retrievers appear to be at increased risk for this type of tumor.

Genetic influences appear to be important in the development of bone tumors in Saint Bernards and Rottweilers. Certain families within these breeds develop more bone tumors than do other families.

The most dramatic example of how genes can influence cancer development is found in the Bull Mastiffs of Great Britain, where it has been estimated that at least 25% of the population has developed or will develop lymphosarcoma.

Hepatoid tumors of the anus (perianal adenomas) are seen five to 10 times more often in aging male dogs than in aging female dogs, probably as an effect of androgens in the male dogs. Lipomas are found more frequently in aging female dogs than in aging male dogs. It is not known if ovariecomy decreases this incidence.

The risk of developing oral neoplasms, particularly fibrosarcoma, is reported to be significantly greater in male dogs than in female dogs. The high-risk breeds include Cocker Spaniels, Boxers, Golden Retrievers, Weimaraners, and German Short-haired Pointers. The Risk for developing oropharyngeal cancer increases with age, particularly in the case of melanomas in dogs more than 10 years old.

VNASA 1994 AGM AND LUNCH

I wish to thank the VNASA Committee and all the VNASA members most sincerely for the **beautiful** clock you presented me with at your recent AGM! I shall always cherish this gift as something very special. Thank you!

At first I thought the clock was made from Red **Mahogany** (*Khaya nyassica*), which is indigenous to countries north of South Africa, like Malawi. When I got home, however, I saw that it was made from Red **Ivory** (also called Pink Ivory) (*Berchemia zeyheri*). This is a special wood, as this tree grows here in our area, around the Pienaar's River Dam and Hartesbeespoort Dam. We even have a young tree that we raised from seed, growing in our garden! Possibly you and your members would be interested to know a little more about this bushveld tree. The following piece comes from "Trees of Southern Africa" (3 volumes) by Eve Palmer and N. Pitman:

Red Ivory timber is famous for quality and colour. It has a particularly fine texture and curly grain, polishes well and is extremely hard, strong, durable and resistant to insect attack and to decay.

In parts of Zululand this is considered a royal tree, chiefs alone carrying knobkieries made of it. The wood is much sought after for carving.

The leaves have an unusual use: when carrying buckets of water, Zulus sometimes place the leaves on the surface of the water to keep it from spilling.

The surplus fruits are stored in baskets where they form a solid brown sugary mass. They are a great delicacy and a concentrated ration on a long journey. Fruits are also dried in the sun for stamping and mixing with porridge. They make a good jam.

Many animals (monkeys, bushbabies and goats) and birds (toppies, barbets, starlings, loeries, doves and Green Pigeons) eat the fruits (that was the reason we planted this tree!). Impalas and nyala eat fruits and leaves and porcupines eat the bark.

The VNASA AGM was conducted in an efficient and friendly manner, which will surely be an incentive for many more qualified Vet. Nurses to attend the symposium and AGM next year! May I wish the new committee everything of the best for the coming year!
